- a) "Bullying and Harassment" section of the general information section: Rationale: The new phone number for the Bullying Hotline was added (Pg 10).
- b) "Inappropriate Dress" section of the Violations Chart: Rationale: The sentence "Any clothing that depicts drugs/alcohol and/or gangs is not allowed." was added to this section based on the decision of the PTSO (pg 20).
- c) "Violations Against Property" section of the Violations Chart. Rationale: The property value increased from \$300 to \$750 to determine

if an incident would be reported as a SESIR based on changes made by FLDOE in the SESIR incident definitions as of January 2023 (pg 29).

V. Topics for Discussion

A. Discussion Item: Enrollment

Enrollment is currently at 328. A few of our grade levels are at capacity

- B. Discussion Item: Proposed Capital Project
 - 1. **Background:** The existing school has seen a significant growth in student population. With the development of the Flowing Well Community and other housing development projects, it is projected that the current facilities will not

be able to meet the needs of the Brighton Community. Some of the current classrooms are at capacity.

- 2. Description of Work/Intended Results: The new 2 or 3-story building will be built west of the expanded cafeteria and will require the removal of the two trailers that currently occupy the space. The facility will have 16 classrooms with storage. By adding a 16 classroom building, the school can add one teacher to each grade level (PreK-8th Grade) and plan on accommodating high school students in some capacity in the future. The project will also include the expansion of the driveway at the front of the school and paving of the perimeter road with a widened area to park the school buses.
- 3. Board recommendations: Procure the land between Pemayetv and Flowing well for future expansion. Chairman Marcellus W. Osceola mentioned the need to prepare for the future and stay ahead of enrollment.
- C. Discussion Item: Assessment Data and School Grade Prediction

Our overall ELA proficiency rate was 66%, our Math proficiency rate was 86%, Science was 68%, Algebra I was 100%, and our Civics proficiency rate was 100%. While school grades won't come back until the end of our first semester, we can be proud of how well our students did and how much they learned. That is a tribute to our educators, our parents, our community, and the support of Tribal Council. Everyone's tireless efforts, unwavering dedication, and passion for education are the driving force behind the success of our school community. Our students earned this grade as a result of their hard work, which is a tribute to their teachers and staff and the tremendous support we receive from Tribal Council, EAO, our parents and family members, the Brighton Community, CSA, and the Glades County School District. Thank you for your tireless support of us and our school.

D. Discussion Item: Campus Active Shooter Simulation.

October 16th at 10:00 am, we will be having an Active Shooter Simulation. Those invited are Tribal Council, Tribal Board, Fire Chief, Chief of Police.

E. Discussion Item: Campus Maintenance and Beautification

Pemayetv wanted to take a moment to express our deep appreciation for the exceptional work being done by the Buildings and Grounds department in repairing, replacing, and maintaining our school facilities. The transformation We've witnessed over the past few months has been remarkable, and it is a testament to leadership and the dedication of the B&G team. Their attention to detail, tireless efforts, and unwavering commitment to excellence have made a significant impact on the overall success of the project. Some of the projects included new drainage systems, gutter and roof cleaning, pressure cleaning, new internet cabling, new flooring in the main office, HVAC repair, filter changes in all ACs, painting the exterior of the building, some interior painting, and carpet cleaning. We will systematically paint more interior classrooms each year, and we will begin replacing carpets soon.
